

ORDINANCE # 319

AN ORDINANCE AMENDING CITY CODE 2.1-2.0601 "SPECIAL STOPS REQUIRED":

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF BUFFALO, IA, THAT SECTION 2.1-2.0601 SHALL BE AMENDED WITH THE ADDITION OF THE FOLLOWING STOP SIGNS:

<u>VEHICLES ON:</u>	<u>TRAVELING:</u>	<u>SHALL STOP AT:</u>
1) SECOND STREET	EAST AND WEST	FRANKLIN STREET
2) MAIN STREET	NORTH	FOURTH STREET
3) SECOND STREET	EAST	DODGE STREET
4) THIRD STREET	EAST	DODGE STREET
5) CHESTNUT STREET	EAST	MAPLE STREET
6) OAK STREET	NORTH AND SOUTH	CHESTNUT STREET
7) MAPLE STREET	SOUTH	FOURTH STREET
8) FOURTH STREET	EAST AND WEST	FRANKLIN STREET
9) FOURTH STREET	EAST	DODGE STREET
10) FIFTH STREET	EAST AND WEST	DODGE STREET
11) SIXTH STREET	EAST	DODGE STREET
12) SIXTH STREET	EAST	HACKER STREET
13) SIXTH STREET	WEST	FRANKLIN STREET

THE FOLLOWING LISTED STOP SIGNS IN THIS CODE ARE INCORRECT AND SHALL BE DELETED:

1) CHESTNUT STREET	SOUTH	OAK STREET
2) DODGE STREET	EAST AND WEST	FIFTH STREET
3) DODGE STREET	WEST	FIFTH STREET
4) DODGE STREET	EAST	SIXTH STREET


All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.
