

ORDINANCE # 343

AN ORDINANCE AMENDING TITLE II, DIVISION 1, CHAPTER 2 BY ADDING A PARAGRAPH CONCERNING OPERATION OF A MOTOR VEHICLE WITHOUT REGISTRATION:

BE IT ENACTED BY THE CITY COUNCIL OF BUFFALO, IOWA, THAT ARTICLE 2 SHALL BE AMENDED TO INCLUDE THE FOLLOWING PARAGRAPH TO READ AS FOLLOW:

2.1-2.0301, SUBPARAGRAPH 18. OPERATION WITHOUT REGISTRATION. NO PERSON SHALL OPERATE, NOR SHALL AN OWNER KNOWINGLY PERMIT TO BE OPERATED UPON ANY HIGHWAY ANY VEHICLE REQUIRED TO BE REGISTERED AND TITLED UNDER THE LAWS OF THE STATE OF IOWA UNLESS THERE SHALL BE ATTACHED THERETO AND DISPLAY THEREON WHEN AND AS REQUIRED BY THE LAWS OF THE STATE OF IOWA A VALID REGISTRATION CARD AND REGISTRATION PLATE OR PLATES ISSUED THEREFOR FOR THE CURRENT REGISTRATION YEAR AND UNLESS A CERTIFICATE OF TITLE HAS BEEN ISSUED FOR SUCH VEHICLE EXCEPT AS OTHERWISE EXPRESSLY PERMITTED IN CHAPTER 321, CODE OF IOWA. A VIOLATION OF THIS SECTION SHALL RESULT IN A SCHEDULED FINE OF \$20.00 PER VIOLATION, (IOWA CODE 321.98, 805.8(1), 911.2)

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

If any section, subsection, sentence, clause, or phrase of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not effect the validity of the ordinance as a whole or any section, subsection, sentence, clause, or phrase hereof not adjudged invalid or unconstitutional.

This ordinance shall become effective upon publication as required by law.
