# C. Park Cameras

i. Troy explained that the company representative would meet with him when the weather improves. Everything was still lined up with the underground boring to be completed at that time for the camera and scoreboards.

## D. Park Signs and Beach Front signs

- a. Sgt. Bujalski explained his view on the park times. He also suggested that the beach be divided into zones so that during emergencies people can identify to first responders their location.
- b. Brandy brought forward her potential changes for the Park signs and Buffalo Park Rules and Regulations.
  - i. It was moved by Basso to change Businesses Prohibited to read: It shall be unlawful for any person to be or act as a ply the vocation of a solicitor, agent, or peddler. And change the park times to read:

#### E. Dodge Street Park

- c. The condition of the batting cage was discussed.
  - i. It was moved by Teel to request that Public Works remove the batting cage from the park. Seconded by Harland and carried unanimously.

#### G. Memorial/River Front/Beach

a. Harland suggested requesting that Pubic works refurbish the gazebo.
