- B. **Roll Call**

- C. **Public Input**
  - a. Sally Rodriguez: Kids were on the roof top of the park building, trash cans were knocked over, new exercise equipment being beat on. This verifies a great need for the park cameras and enforcement of them, asked for more patrolling of the parks until then.
