Ordinance 457

An amendment authorizing the City of Buffalo, Iowa to increase their existing Building Rate Fee and charges.

WHEREAS, the City of Buffalo supports a building code for citizen safety; and,

WHEREAS, from time to time it becomes necessary to increase building rate fees in order to offset expenses in the building department.

NOW THEREFORE BE IT RESOLVED that the City Council, of the City of Buffalo, Iowa, hereby amends the Buffalo Municipal Code as follows:


Full force and effect. This ordinance shall be in full force and effect from the date of passage and publication as required by law.

If any section, subsection, sentence, clause, phrase, or portion of this ordinance be held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision as such holding shall not affect the validity of the remaining portion hereof.
