#### I. SPECIFIC REQUIREMENTS

## 1. Definitions.

- (a)4 restrooms (by city hall, in gym, by Food Pantry, by Library)
  - 1. Clean toilets, sinks, urinals, mirrors, fixtures, partitions and walls
  - 2. Empty trash
  - 3. Stock toilet paper, paper towels, hand soap
  - 4. Mop floors
- (b) City Hall
- 1. Empty trash
- 2. Vacuum
- (c) Building
- 3. Vacuum hallways
- 4. Mop gym entrance and east side hallway
- 5. Wipe down window ledges and display area
- (d)Gym
- 6. Clean the counters, stove top, microwave, and sink in the kitchen.
- **Indemnification**. The CONTRACTOR hereby agrees to indemnify and protect the CITY OF BUFFALO from all suits, claims, and actions brought against it, and all costs or damages, which the CITY OF BUFFALO may be put to by reason on injury, to the person or property of another in the execution of this contract, or the performance of said work, and to this end the CONTRACTOR agrees at all times hereunder to keep itself insured against liability in the following amounts:
  - 1. Workmen's Compensation as required by statute;
  - 2. Public Liability and Property Damage:

\$500,000 Each combined single incident

\$250,000 Motor Vehicle Bodily Injury per person

\$500,000 Each accident

\$1,000,000 Property damage

\$1,000,000 Excess, Blanket Basis, Liability Umbrella

Prior to cleaning, the CONTRACTOR shall name the CITY as a co-insured and file with the CITY Clerk certificates of insurance evidencing such coverage. Such certificates, or their replacements, shall be continuously on file with the CITY during the full term of this contract.
